3. Payment Terms

Non-Refundable Retainer: \$50 retainer due at contract signing.

Remaining Balance: due no later than at the start of the service. Payments can be made via online at my website or in person. No services will be rendered without full payment.

4. Travel & Parking

Travel fees may apply if the Artist is required to travel more than 45 minutes from King of Prussia, PA. Client

agrees to cover all parking, valet, or toll fees incurred as a result of the services rendered.

5. Changes & Cancellations

All changes must be submitted in writing. The retainer is non-refundable and secures the date and time of service. Cancellations within 30 days of the wedding date are subject to a cancellation fee of 50% of the total agreement.

Client agrees that should the event get canceled for reasons beyond their control (whether due to medical emergencies or natural weather events), they will only be responsible for paying their initial deposit plus travel/lodging fees if already incurred.

6. Delays

Client agrees to ensure that all members of the party are present and ready at their scheduled time. The Artist is not responsible or liable for any delays in service or incomplete applications due to late arrivals or unprepared members of the party.

7. Artist Obligations

Artist agrees to:

- Arrive on time, with a fully sanitized and professional kit.
- Provide services to the best of her professional ability.
- Maintain a clean and safe working environment. In the unlikely event the Artist is unable to perform services due to serious illness or emergency, every effort will be made to secure a qualified replacement. If none is available, a full refund will be issued.

8. Client Responsibilities

Client agrees to:

- Communicate all skin allergies, sensitivities, or concerns prior to the service.
- Ensure clean, makeup-free faces prior to service start time.
- Notify the Artist immediately if they are dissatisfied with any aspect of their makeup during the service. If the Client fails to communicate dissatisfaction or fails to request desired modifications to the look during the service, the Client agrees not to post negative reviews or comments on social media, review platforms, or other public forums regarding the makeup look.

9. Use of Images

With the Client's written consent, Artist may use photos or videos taken during or after services for portfolio, website, and social media marketing. Client may opt-out by checking the box below:
